

<u>Aquatic Invasive Species (AIS) Prevention: LSA Watercraft</u> <u>Controlled Access Entry and Cleaning Pilot Program</u>

Introduction

- Watercraft are considered the greatest risk of introducing an Aquatic Invasive Species into a water body due to their mobility and ability to transport organisms over long distances quickly. This is particularly true for recreational boats which are often moved between waterbodies by their owners without taking appropriate precautionary cleaning measures.
- 52% of the 2024 LSA Aquatic Invasive Species Questionnaires returned by members support a more aggressive approach towards implementation of countermeasures associated with AIS prevention for Lake Summerset.

Program Description

- Implement a Pilot Program for the 2025 Boating Season (Calendar Year 2025) that would control entry and enforce cleaning protocols of motorized and non-motorized watercraft into Lake Summerset. This would include the following:
 - 1. All motorized and non-motorized watercraft should only enter Lake Summerset through the manual lane at the Main Guardhouse. Access into the community through any automated gate is not recommended and would be contradictory with the goals of this program.
 - 2. See <u>Exhibit 1</u> for the Entry Process and Procedure Specifics. The checklist card listed in the procedure definition provides a simple means for guardhouse staff to determine "Entry" or "No Entry" allowance of watercraft through the main gate and will also be used to develop a database of watercraft entries for future policy decisions.
 - 3. Any motorized or non-motorized watercraft not registered with Lake Summerset is prohibited from entry into the community. Members that own watercraft which are not used on Lake Summerset (due to member preference or size/HP restrictions) can request an "Entry Only" decal from the LSA Office which must be displayed toward

the stern on the port side of the watercraft. The issuing of the "Entry Only" decal does not require a full watercraft registration through the LSA Office where HP, length, state registration and proof of insurance are required. A record will be kept in YOTZ as to which members are issued the "Entry Only" decal. The presence of this decal on the watercraft will allow entry with minimum delay. Entry must still occur through the Manual Lane at the Guardhouse, but filling out the watercraft entry card will not be required. Any watercraft displaying an "Entry Only" decal is prohibited from use on Lake Summerset.

 Congestion at the Guardhouse due to this new proposal is not anticipated based on the number of members using their watercraft on waterways other than Lake Summerset (per the Aquatic Invasive Species Questionnaire data). Since this is a non-zero number, the risk to Lake Summerset is present due to this situation.

Timeline

- 1. Present proposal to Board for comments and feedback August BOD Meeting
- 2. Revise proposal based on comments and suggestions and present it for approval at the November BOD Meeting.
- 3. If accepted, start a trial period in effect for the Calendar Year 2025 as of January 1st.
